

# PRICE STRUCTURE FOR ONLINE PROGRAM

## FLEXIBLE ENROLLMENT OPTIONS

The original face-to-face program has now been converted to online mode. The full course is comprised of six modules, and each contains a video and opportunity to contribute to discussion forums.

All modules are self-paced, so registrants can complete these at any time. A Certificate of Completion will then be issued, which can be used toward claiming Continuing Professional Development (CPD) hours from the Australian Association of Social Workers (AASW), Australian Psychological Society (APS), or other relevant professional association (nationally and internationally).

Registrants are encouraged to enroll in the full course, as holistic knowledge is in the best interest of CALD victims/survivors of child sexual abuse, and their families and communities (and a 10% discount on the full price is offered). However, it is acknowledged that practitioners are time-poor, under-resourced, and conduct crisis-driven work. Thus, flexibility in module enrollment is also offered. The following table summarises the various price structures (in Australian dollars):

- **Bundle # 1** is recommended for protecting the cultural safety of CALD communities, and for practitioners looking for theoretical frameworks to help contextualise their practice wisdom.
- **Bundle # 2** is recommended for practitioners already strong on theory, and more looking for translation to practice in organisational settings.
- **Bundle # 3** is recommended for interpreters engaged in matters relating to sexual assault and/or domestic and family violence.
